Sir,

In producing herewith arrested accused persons namely Ashwini Kumar (19 yrs) s/o Kiriti Kumar of vill.- Tatuara, PS, Kotshila, Dist.- Purulia along with seized one Mahindra 275 NBP MKM BS3 tractor (red colour) without number plate bearing Chassis No. RFNB01760 , Engine No. RFNB01760 attached with one trolley loaded with sand under proper seizure list , I beg to submit that today (18/02/2022) I along with (1) C/1524 Krishna Chandra Mahato, (2) C/1279 Bhabataran Mahato both of Kotshila P.S were performing Mobile duty vide Kotshila PS CC No. 438/22 Date- 18.02.2022. During my mobile duty at about 13.45 hrs I along with force reached at Chamchaka village road near stone crusher under Kotshila PS and found that a red colour Mahindra tractor without number plate attached with trolley loaded with sand was coming from Chamchaka village side. On seeing the Police party near at stone crusher, the driver of the said tractor was trying to fled away. But after a hot chase, we could able to detain the driver of said tractor. I asked the driver Ashwini Kumar to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. During interrogation he confessed that he loaded the tractor with sand by illegal manner for selling the same to make profit by dishonestly for running clandestine business consent with owner of the vehicle. So, I seized the tractor without number plate bearing Chassis No. RFNB01760, Engine No. RFNB01760 attached with trolley under proper seizure list in presence of available witnesses duly signed by them and I arrested Ashwini Kumar (19 yrs) s/o Kiriti Kumar of vill.- Tatuara, PS, Kotshila, Dist.- Purulia. As such there is every reason to believe that the driver and owner of the tractor with ill motive are habitually dealing with sand illegally for selling the same to make profit by dishonestly for running a clandestine business without any valid document. So they are liable for offence punishable U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act' 1957.

Therefore, I pray before you that a case against namely Ashwini Kumar (19 yrs) s/o Kiriti Kumar of vill.- Tatuara, PS, Kotshila, Dist.- Purulia and owner of the tractor may kindly be started and arrange for its investigation.
