Sir,

In producing herewith the following seized 03 (three) nos of Motor Cycle i.e (1) One Black colour Hero Honda Splendor without registration number having Chassis No. 98K19F07947 Engine No. 98K17E07292 loaded with coal 03 quintal (approx) (2) One Black Colour Old Motor cycle without any model, registration number or engine number and Chassis number loaded with coal 03 quintal (approx) and (3) One Grey colour Bajaj Classis Scooter without any registration number, engine no. and chassis no. loaded with coal of 03 quintal (approx) and accused (1) Ashtami Nayak (32 yrs) s/o Jay Prasad Nayak of vill. Chando, PS- Petarwar, (rider of Hero Honda Motor Cycle) (2) Alku Ghansi (47 yrs) s/o Lt. Ram Kishan Ghansi of vill. Baru tola Kharbarbeda PS- Jaridih (rider of black colour old motor cycle with registration number, engine no. and chassis no.) and (3) Tinku Nayak (26 yrs) s/o Makund Nayak of vill. Chando, PS- Petarwar, all of Dist.- Bokaro (Jharkhand) (rider of Bajaj Classis Scooter without any registration number, engine no. and chassis no) do hereby lodge complaint to the effect that today (20/02/22) at 13.15 hrs, in course of day mobile duty, I had information to the effect that 03 nos of Motor Cycle loaded with coal of 03 quintal (approx) in each motor cycle were coming from Jaridih side (Jharkhand) towards Guridih village, PS- Kotshila, Dist.- Purulia. I along with force namely C- 1279 Bhabataran Mahato & C- 633 Dasarath Singh Mura immediately rushed there at 13.45 hours. I found the said vehicles were approaching towards Chitmu VIP More. I stopped those motor cycles at 13.55 hours near Chitmu VIP more on Guridih- Chitmu- Chamchaka village road approaching towards Chitmu VIP more. I found the said motor cycles were loaded with coal of 03 quintal (approx) in each motor cycle. On interrogation the above accd persons could not produce any paper in r/o possession & transportation of the coal and in r/o the vehicle.

On Interrogation, all the 03 (three) rider accused namely Ashtami Nayak, Alku Ghansi and Tinku Nayak also disclosed that they are as usual to take the illegal coal with the motor cycle from Jaridih side (Jharkhand)

It is found that, all the riders have been transporting said illegal coal by that motor cycles from Jharkhand side and transporting the same in a clandestine manner to another dist/state. They are dealing this business since long time. Accordingly (1) One Black colour Hero Honda Splendor without registration number having Chassis No. 98K19F07947 Engine No. 98K17E07292 loaded with coal 03 quintal (approx) have been seized from the possession of Ashtami Nayak (32 yrs) s/o Jay Prasad Nayak of vill. Chando, PS- Petarwar (2) One Black Colour Old Motor cycle without any model, registration number or engine number and Chassis number loaded with coal 03 quintal (approx) have seized from the possession of Alku Ghansi (47 yrs) s/o Lt. Ram Kishan Ghansi of vill. Baru tola Kharbarbeda PS- Jaridih and (3) One Grey colour Bajaj Classis Scooter without any registration number, engine no. and chassis no. loaded with coal of 03 quintal (approx) have been seized from the possession of Tinku Nayak (26 yrs) s/o Makund Nayak of vill. Chando, PS- Petarwar, all of Dist.- Bokaro (Jharkhand) under proper seizure list duly signed by the Police witnesses in between 13.55 hrs and 14.25 hrs, since no Local People was found & none turned up as witness. I arrested the above accds. from 14.35 hrs to 14.45 hrs respectively & Issued them Arrest memos. I also weigh all the motor cycles loaded with coal weigh bridge Kotshila and collect the memo from weigh bridge authority.

Under the above circumstances a specific case may kindly be started against accused (1) Ashtami Nayak (32 yrs) s/o Jay Prasad Nayak of vill. Chando, PS- Petarwar, (rider of Hero Honda Motor Cycle) (2) Alku Ghansi (47 yrs) s/o Lt. Ram Kishan Ghansi of vill. Baru tola Kharbarbeda PS- Jaridih, (rider of black colour old motor cycle with registration number, engine no. and chassis no.) and (3) Tinku Nayak s/o Makund Nayak of vill. Chando, PS- Petarwar, all of Dist.- Bokaro (Jharkhand)
