Sir,

In producing here with arrested accused persons namely 1) Debasish @ Suraj Kumar (28 yrs) s/o Lt. Krishna Kumar of vill.- Belyadih, PS- Kotshila, Dist.- Purulia 2) Pintu Dan (34 yrs) s/o Rabindranath Dan of vill.- Begunkodar, PS- Kotshila, Dist.- Purulia and seized articles (1) one sword length approx 2 feet 7 ½ inch (approx) out of which 2 feet 2 inch sharpen portion and 5 ½ inch butt (2) One country made pipe gun (iron made) length 13 ½ inches (Butt – 4 inches, Body – 4 inches & Barrel- 5 ½ inches) having iron butt, body, barrel, trigger, firing pin etc and (3) One 70 mm live ammunition marked as “ASTRAM MAGNA” lodged complaint against them and their other associates to the effect that on 21.02.2022 at about 00.15 hrs received a credible tip that a gang of dacoits being armed with deadly weapons like fire arms assembled in a patch of jungle near Tali Centre beside Tali Centre – Barahankal Village road adjacent to Bamun Bandh and they were preparing themselves for committing dacoity at Bamnia side. This matter was informed to O/C Kotshila PS and Duty Officer ASI Tushar Kanti Mandal to note down the information down to the GDE Vide Kotshila PS GDE No 854 Dated 21/02/22. On getting the tip off as per kind order of O/C Kotshila PS myself accompanied with officer & force namely ASI Pankaj Gupta C/1543 Prabir Mandal, C/332 Ashok Kr. Kandu and C/292 Kritibas Mahato all of Kotshila PS vide CC No. 455/22 dated 21/02/22 immediately proceeded to the anticipated place of assembly to work out the information and reached near Tali Centre at 01.05 Hrs leaving the Police vehicle No. WB 26C -7292 and started to proceed for the anticipated place on foot. At 01.35 Hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that a gang of 10/12 persons assembled in the beginning of the jungle by the side of village road near Tali Centre beside Tali Centre-Barahankal village road adjacent to Bamun Bandh and those persons were whispering from which it was clear that they were preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed to ours words and tried to flee away. We succeeded to nab in rounding up only 02 (Two) of them at 01.55 Hrs while the rest were managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them that we want to search them and if necessary they can search us, but they informed us that they are not willing to search us. Then after observing all formalities I searched the above noted apprehended persons and recovered one country made pipe gun length 13 ½ inches (Butt – 4 inches, Body – 4 inches & Barrel- 5 ½ inches) having iron butt, body, barrel, trigger, firing pin etc loaded with one 70 mm live ammunition marked as “ASTRAM MAGNA” from the exclusive possession of Debasish @ Suraj Kumar and one sword length approx 2 feet 7 ½ inch (approx) out of which 2 feet 2 inch sharpen portion and 5 ½ inch butt from the possession of Pintu Dan. Then in between 02.05 hrs 21/2/22 to 02.35 Hrs on 21/02/22 from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities I, seized (1) One country made pipe gun length 13 ½ inches (Butt – 4 inches, Body – 4 inches & Barrel- 5 ½ inches) having iron butt, body, barrel, trigger, firing pin etc (2) One 70 mm live ammunition marked as “ASTRAM MAGNA” and (3) one sword length approx 2 feet 7 ½ inch (approx) out of which 2 feet 2 inch sharpen portion and 5 ½ inch butt under proper seizure list as well as labeled duly signed by the apprehended persons and witnesses as Alamat property in c/w above case. Then from 02.45 hrs to 02.55 hrs I arrested 02 (two) persons namely 1) Debasish @ Suraj Kumar (28 yrs) s/o Lt. Krishna Kumar of vill.- Belyadih, PS- Kotshila, Dist.- Purulia 2) Pintu Dan (34 yrs) s/o Rabindranath Dan of vill.- Begunkodar, PS- Kotshila, Dist.- Purulia. Issued Memo of arrest and observe all legal formalities of arrest, also inform then regarding ground of arrest and inform to their family members. On interrogation they confessed their guilt and they stated that they have assembled there with 8/10 others namely Swarnendu @ Senior Kumar s/o Ashwini Kumar, Dulu Das Baisnab s/o Lt. Hiru Das Baisnab, Makhan Kumar s/o Gurupada Kumar all of vill.- Chekya, Dharma Kumar s/o Bhagbat Kumar, Kudur Kumar s/o Aruni Kumar both of vill.- Belyadih, and Sharukh Seikh s/o Nantu Seikh of vill.-Dangal all of PS- Kotshila, Dist.- Purulia and others for committing house dacoity at Bamnia village Side.

I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place and I got information they assembled and making preparation for committing dacoity armed with deadly fire arms and weapons which might be dangerous for life of public witnesses, so I restrained collecting witnesses. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I arrested them preparing arrest memo and ground of arrest was duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely 1) Debasish @ Suraj Kumar (28 yrs) s/o Lt. Krishna Kumar of vill.- Belyadih, PS- Kotshila, Dist.- Purulia 2) Pintu Dan (34 yrs) s/o Rabindranath Dan of vill.- Begunkodar, PS- Kotshila, Dist.- Purulia , along with associates namely Swarnendu @ Senior Kumar s/o Ashwini Kumar, Dulu Das Baisnab s/o Lt. Hiru Das Baisnab, Makhan Kumar s/o Gurupada Kumar all of vill.- Chekya, Dharma Kumar s/o Bhagbat Kumar, Kudur Kumar s/o Aruni Kumar both of vill.- Belyadih, and Sharukh Seikh s/o Nantu Seikh of vill.-Dangal all of PS- Kotshila, Dist.- Purulia and others under proper section of law.
