Sub: Complaint against Rajib Mandi (28 y), S/O- Loso Mandi of Vill-Gurrabera, PS - Kotshila,  
Dist - Purulia, to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. Rajib Mandi (28 y), S/O- Loso Mandi of Vill-Gurrabera, PS - Kotshila, Dist - Purulia with seizure of approx 17 (Seventeen) liters illicit liquor from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (23.02.2022) during mobile duty on acting secret source information I held raid 13:15 hrs in the house of above noted person at Gurrabera village who was stocked illicit spirit in his house. I searched the place and found approx 17 (Seventeen) Liters illicit spirit which was kept in a white colour Jaricane. On interrogation he disclosed his name and address as noted above and also stated that he uses to sell the same for his gain in lieu of money. On demand he failed to produce any valid documents in respect of illicit spirit which is kept in his house. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith in between 14:55 hrs to 15:25 hrs. As such he was arrested at 15:35 hrs U/S- 67 B.E. Act and during arrest the ground of arrest was duly notified issuing arrest memo U/S- 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 500 (Five Hundred) M.L was taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Rajib Mandi (28 y), S/O- Loso Mandi of Vill-Gurrabera, PS - Kotshila, Dist - Purulia violate section 18 (i) B.E. Act. for possession and selling of intoxicating not obtained from a licensed vendor and in contravention and he Committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid (1) C/292 Kritibas Mahato (2) C/332 Ashok Kr. Kandu, accompanied me Vide Kotshila P.S C.C No 475/2022, Dated 23.02.2022.

Under the fact and circumstance I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against arrested accd person namely Rajib Mandi (28 y), S/O- Loso Mandi of Vill-Gurrabera, PS - Kotshila, Dist - Purulia.


