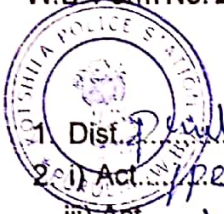



In producing herewith arrested accused persons namely Brihaspati Mahato (36) s/o Malindra Nath Mahato of vill.- Bhelatanr, PS- Kotshila, Dist.- Purulia along with seized one tractor without number plate bearing Chassis No. 1VY5105DLMA023883, Engine No. PY3029D608131 attached with trolley loaded sand under proper seizure list, I beg to submit that today (15/02/2022) I along with (1) C/1543 Prabir Mondal (2) C/1279 Bhabataran Mahato both of Kotshila P.S were performing Day Mobile duty vide Kotshila PS CC No. 396/22 Date-. 15.02.2022. During my mobile duty at about 14.05 hrs I along with force reached at Kochahatu village More under Kotshila PS and found that a green colour tractor without number plate of named as 'JOHN DEERE' attached with trolley loaded with sand was coming from Rampur village side. On seeing the Police party at Kochahatu more, the driver of the said tractor was trying to fled away. But after a hot chase, we could able to detain the driver of said tractor. I asked the driver Brihaspati Mahato to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. During interrogation he confessed that he loaded the tractor with sand by illegal manner for selling the same to make profit by dishonestly for running a clandestine business consent with owner namely Uttam Mondal s/o Gurupada Mondal of vill.- Nagra, PS- Arsha, Dist.- Purulia. So, I seized the tractor without number plate bearing Chassis No. 1VY5105DLMA023883, Engine No. PY3029D608131 attached with trolley under proper seizure list in presence of available witnesses duly signed by them and I arrested Brihaspati Mahato (36) s/o Malindra Nath Mahato of vill.- Bhelatanr, PS- Kotshila, Dist.- Purulia. As such there is every reason to believe that the driver and owner of the tractor with ill motive are habitually dealing with sand illegally for selling the same to make profit by dishonestly for running a clandestine business without any valid document. So they are liable for offence punishable U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against namely (1) Brihaspati Mahato (36) s/o Malindra Nath Mahato of vill.- Bhelatanr, PS- Kotshila, Dist.- Purulia (2) Uttam Mondal s/o Gurupada Mondal of vill.- Nagra, PS- Arsha, Dist.- Purulia (owner of tractor) may kindly be started and arrange for its investigation.
