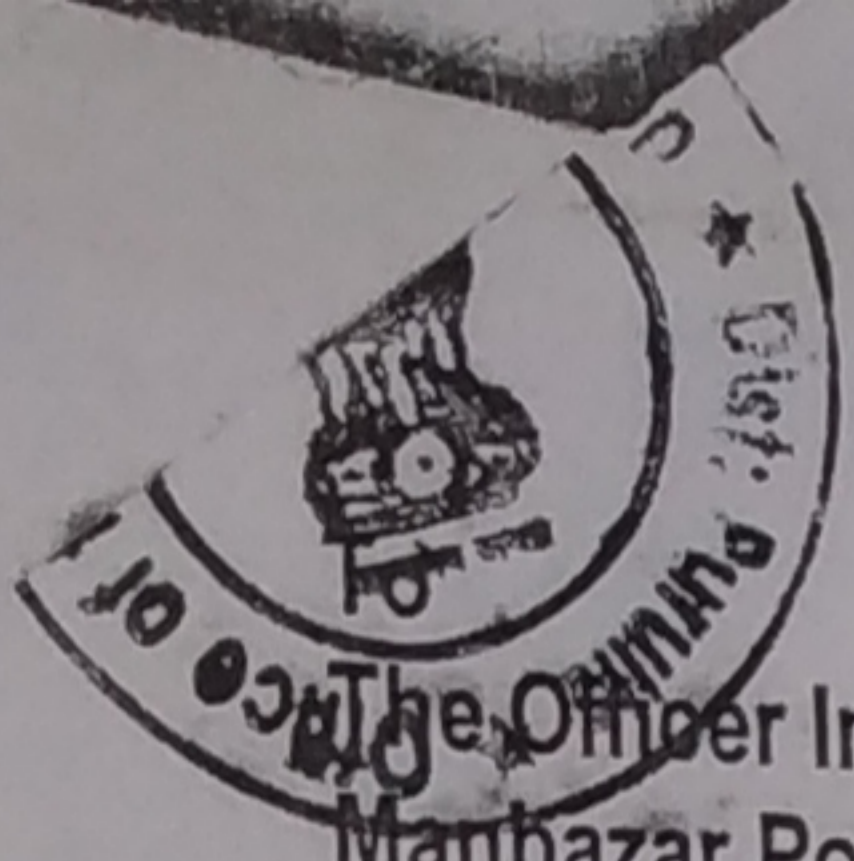

Sir,

In producing here with 15 (Fifteen) accused persons namely 1). Jiten Kumbhakar (50) S/O Lt. Jashoda Kumbhakar of village – Shyampur, 2) Nisith Mahato (41) S/O- Lt. Bidyadhar Mahato village - Bisri, 3) Jahar Paul (55) S/O Lt. Shaktipada Paul village - Manbazar Das Para ,4) Mahadeb hansda (42) S/O- Lt. Santosh hansda village - Patharkata, 5) mahananda sarkar (33) S/O Lt. Ranjit sarkar village - Manbazar Majh Para 6) Dinesh Dey (50) S/O-Lt. Prakash Ch. Dey village Manbazar Poddar Para, 7) Raghunath Mukherjee (42) S/O- Lt. Haradhan Mukherjee village Manbazar Namo Para 8) Abhilash Bauri (66) S/O- Lt. I beg to state that today (31.01.22), I was directed to find out whether the Govt. Restriction order vide 753/XX – ISS/2M-22/2020 dated 15.01.2022 regarding COVID-19 has been followed properly at Manbazar Town area or not. This refers to Manbazar PS GDE No.1063 Dtd. 31.01.22 and C.C. No- 221/22 . Accordingly, I along with C/460, Nirmalendu Sinha Mahapatra C/531 Shib Sankar Mahanty had been at Post office morh Manbazar and found the above noted persons were moving freely in that public place without wearing Mask. Thus they violated COVID -19 protocol as promulgated by Govt.of West Bengal Vide Order No- 753/XX – ISS/2M-22/2020 dated 15.01.2022,, Extended till 31st January 2022 and desperately to spread infection of deceases dangerous to life.

I arrested them for Disobedience to order duly promulgated by the Govt. of West Bengal as above after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regarding the ground of arrest.

All the process was done in between 14.15 hrs and 15.45 hrs. There was every chance of breach of peace and requiring of offence if not arrested.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to OC Manbazar PS through duty officer S.I. Banshidhar Mukherjee for taking necessary action as per law.
