In producing here with one accused person Gadadhar @ Ananda Murmu (61Yru) S/O-Kshudiram Murmu village Jharbagda P.S. Manbazar, Dist - Purulia along with following seized articles viz-

- (1)20 (Twenty) Ltrs ID liquor within a Plastic Jarikane
- (2) 10 pieces plastic glass
- (3)375 M.L ID liquor collect from the Jarikane as sample

I S.I. Biswarup Roy of Manbazar PS hereby lodged a complaint against accused namely Gadadhar @ Ananda Murmu (61 Yrs) S/O-Kshudiram Murmu village Jharbagda P.S. Manbazar, Dist - Purulia to the effect that today (01.02.22) at 16:05 hrs. I received a telephonic information from a reliable source that one Gadadhar @ Ananda Murmu (61 Yrs) S/O-Kshudiram Murmu village Jharbagda P.S. Manbazar, Dist - Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain. Then I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1353 Atanu Ganguly and C/ 200 Dasarath Mahato rushed to the spot for raid by Govt. vehicle. At about 17:05 hrs. myself along with force reached at Jharbagda near College Hostel and held raid in the house of Gadadhar @ Ananda Murmu and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Gadadhar @ Ananda Murmu tried to conceal himself but we were able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Gadadhar @ Ananda Murmu (61Yrs) S/O-Kshudiram Murmu village Jharbagda P.S. Manbazar, Dist - Purulia as per law and arrange for its investigation.
