

Sir,

In producing here with one accused person Swapan Saren (39) S/O Lt. Nagendra Saren of Village - Surigora ,PS- Manbazar, Dist- Purulia along with following seized articles viz:-

- (1) 20 (Twenty) Ltrs ID liquor within a plastic Jarikan
- (2) 10 (Ten) pieces plastic glass
- (3) 375 M.L ID liquor collected from Jarikan as Sample

I S.I. Sanjib Kr Chatterjee of Manbazar PS do here by lodged a complaint against accused namely Swapan Saren (39) S/O Lt. Nagendra Saren of Village - Surigora ,PS- Manbazar, Dist- Purulia to the effect that today (18.02.2022) at 17:55 hrs. I received a telephonic information from a reliable source that one Swapan Saren (39) S/O Lt. Nagendra Saren of Village - Surigora ,PS- Manbazar, Dist- Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Manbazar PS GDE No- 691/22 Dtd 18.02.2022. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/336 Kartick Ch Roy, C/967 Basudeb Singh Mura rushed to the spot for raid by Govt. vehicle. At about 18:30 hrs, myself along with force reached at Surigora village and held raid in the house of Swapan Saren and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Swapan Saren tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Swapan Saren (39) S/O Lt. Nagendra Saren of Village - Surigora ,PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
