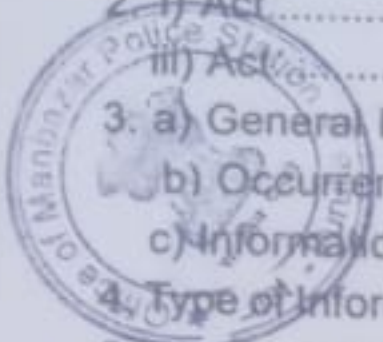

- 1.---That the complainant and the present accused persons are residents of village Udaipur, P.S.Manbazar, Dist.Purulia.
- 2.---That sometime past the accused persons No.1 to 5 were behaving very roughly with the complainant and his family members. They use to thretened and uttered very filthy and slang languages to the complainant. But the complainant any how tolerated all such aforesaid trouble in order to avoid dispute and breach of peace.
- 3.---That on 09-01-2022 at about 6 P.M. when the complt. returning his house from Manbazar Market with Rs.10,000/- (Rupees Ten thousand) which was kept in his pocket. Gurupada Bauri accompined him .When they reached at Pasir Gorla present accused No.1 to 5 namely i) Sunil Bauri, ii) Notan Bauri, iii) Kafi Bauri, iv) Rajina Bauri and v) Sambhu Bauri ^{with} grevious weapons appeared there and encircled the complainant and abused him in filthy and slang languages and assaulted the complainant by fists and blows and extortion of Rs.10,000/- (Ten thousand) from the pocket of the complainant and torned the shirt of the complainant. Accused Sunil Bauri tried to assault the complainant by lathi for common intention to murder the complainant but the complainant any how saved his life and fled away from the place of occurrence, but the accused person threaten the complainant to murder him ~~and~~ they get a chance.
- 4.---That the above named complainant infomed the above inci~~er~~ incidence to the local police of Manbazar P.S. on 10-01-2022
