Sir.

In producing here with 03 (Three) arrested accused persons namely (1) Sangram Mahato (22) S/O Mantu Mahato (2) Buddheswar Mahato (36) S/O Lt- Gopal Mahato (3) Prasanta Mahato (26) S/O Ambuj Mahato all are of village - Sindurpur, PS- Manbazar, Dist- Purulia along with seized motor Cycle under proper seizure list, arrest memos & other relevant papers.

I beg to state that today (21.02.2022), in course of my mobile duty (vide Manbazar PS GDE No- 801, dtd 21.02.2022) I had been to Indkuri more area at about 15:05 hrs and found that the above noted persons with their Motor Cycle having registration No JH05BQ 7021 were roaming aimlessly at Indkuri more area by rough and negligence driving with triple riding. Myself along with force signed to stop him but driver of the Motorcycle drove speedily and disobediently. We could be able to detain them at near Indkuri morh Bypass on Purulia -Barabazar road under Marbazar PS area after a hot chasing. This rough and negligence driving would lead to an accident at any time. Being asked the above accused persons could not be able to give any satisfactory answer for that movement on road and public place by such rough driving.

So I arrested them for disobeying the order duly promulgated by public servant, after maintaining al rules of arrest, Issued memo of arrest. I informed them regarding the ground of arrest and arranged for informing their relatives. They were driving the motor cycle on public way in rash and negligently as to endanger to human life. On being asked they did not produce the valid documents in respect of said motor cycle.

So I seized motor cycle bearing registration No. JH05BQ 7021 (Model Hero glamour, color Blue) after preparing proper seizure list duly signed by the accused persons and witnesses. All the process was done between 15:05 hrs and 15:35 hrs.

So a specific case may be initiated against them as per law and arrange for its investigation.
