The above name complainant begs to state as follows:

- 1) That the complainant and the accused persons are the permanent resident of village- Basudih, P.S. Manbazar, Dist- Purulia.
- 2) That at the time of incident i.e. on 16/01/2022 corresponding to 2nd Magh 1428 B.S. at about 8:00 am the complainant went to the village more of the village for purchasing some articles, when the complainant was taking tea in the house of Dilip Bauri at that time the above noted two accused persons appeared therein and without any provocation harrelled some abusive languages towards the complainant, at that time the complainant protested their such languages they there was some hot altercation in between them.
- 3) That in course of altercation the above noted said two accused persons all on a sudden assaulted the complainant with fest and blows for which the complainant fell down on the ground, but the accused persons did not spare the complainant and continued assaulted him for which the complainant sustained minor injury on his person.
- 4) That in course of scuffling those two accused persons have taken a cash of Rs. 1,200/- which was kept in the pocket of the complainant for purchasing articles.

- 6) That the accused persons committed various offences punishable under the Indian penal code for which they are deserved to be punished under the law.
- 7) That the matter was reported to the Officer-in-charge Manbazar P.S. against the accused those accused persons, but the said Officer-in-charge did not taken any legal action then the complainant lodged another complaint to the Superintendent of Police, Purulia but with same fate, then the complainant is under compelling circumstances is filing this complaint before the Ld. Court for appropriate reliefs under the law.
