Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Basantoy Maji (52 Years) S/O- Lt. Srihari Maji of Vill-Puapur, PS-Neturia, Dist-Purulia with seizure of 15 pcs sealed bottles of Bumper Country spirit containing 300 ml each (MRP Rs. 28/Each) which were seized under proper seizure list.

I beg to submit that today (18.02.2022) while I, ASI Bachchu Ghosh, along with force were performing road duty vide Neturia PS GDE No-516 Dt. 18.02.2022 and acting on source information after consulting you at about 18:35 hrs reached at Paapyr More and held raid in the hotel of Basantoy Maji (52 Years) S/O- Lt. Srihari Maji of Vill-Puapur, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his hotel, on demand Basantoy Maji failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 15 pcs sealed bottles of Bumper Country spirit containing 300 ml each which were seized under proper seizure list duly signed by witness and labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Lt. Apex Court, NIRC & WPHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s- 50 Cr. P.C. and handed a copy of the same to arrested.

The arrested accused namely Basantoy Maji (52 Years) S/O- Lt. Srihari Maji of Vill-Puapur, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.


