Sub:- Complain for starting a specific case .

Sir.

In producing herewith one arrested accused namely Sk Mannat Hossain (32 years ) S/O-Sk Rafik of Vill-Namodigha ,PS-Neturia ,Dist-Purulia along with one seized Mahindra 475 DI tractor having registration No- WB 55B/4627 along with trolley loaded with sand approx 100 Cft. under proper seizure list. I beg to submit that I, SI Shib Narayan Singh along with C/805 Narayan Chandra Dhibar, C/1319 Soumen Koley and C/3180 Ratan Nayek all are of Neturia PS were performing night mobile duty vide Neturia PS GD No- 978/22 Dt. 21.02.22 and at about 23:45 hrs received a credible source information that one Tractor was coming from Sarbari side towards Inanpur side loaded with sand illegally. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Inanpur village side. On 22/02/22 at about 00:05 hrs we reached at Inanpur and found that one tractor is coming from Sarbari side and we stopped the vehicle and found that the tractor with trolley having registration number WB 55B/4627 is loaded with sand . I asked the driver to produce valid documents of the vehicle as well as loaded sand but he failed to produce any valid documents or papers of vehicle as well as loaded sand .On being asked he disclosed his identity as noted above and stated that he is the registered owner of the said vehicle .On preliminary enquiry and his statement it could be learnt that he procured said sand from different illegal area.

So, there is reason to believe that the driver as well as registered owner of the vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, he was trying to dispose of the same sand in a clandestine manner to Inanpur village side knowing it to be stolen as per his regular practice.

Accordingly, I seized the Tractor having registration number WB 55B/4627 along with trolley, loaded with sand approx 100 C.Ft. under proper seizure list duly signed by him and witnesses and also arrested the driver as well as the registered owner after preparing arrest memo. In course of arrest I notified him ground of arrest ,issued arrest memo U/S-50 Cr.PC.Brought him PS with seized tractor along with trolley having registration number WB 55B/4627 with loaded sand .So, the driver as well as registered owner of the tractor has committed offence U/S-379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver and registered owner of the above noted seized tractor U/S- 379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
