I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sekh Ali Mohammad**, **S/O-Sekh Guljar**, a permanent resident of **Vill- Nimdanga P.O - Neturia P.S -Neturia**, **Dist- Purulia** has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 23.02.2022 at about 1:30PM I, Dhritiman Sardar S/O- Rupal Sardar, aged about 24 years, AE & SM Saltore CCC, along with Sri Souvik Mudi, J.E. (Gr-II), Saltore CCC, Satya Rajwar, Sr. TSH, Saltore CCC, and others had been to the village- Nimdanga for routine inspection purpose. During inspection it was found that Sekh Ali Mohammad was consuming electricity dishonestly in his Domestic premises having GPS co-ordinates 23.654520,86.802158 consuming electricity unauthorisedly by the way of direct hooking from nearby LT mains of WBSEDCL causing considerable loss of revenue of WBSEDCL to the tune of load 0.35 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and one number two core flat type black coloured 6 sqmm alluminium core PVC cable along with hooking devices of assorted size has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sekh Mohammad Ali acknowledged the same by putting his signature in the Seizure List, Inspection Report and label.
