I, Jasbir Singh S/O Late Gurmeet Singh, Resident of House No-57, Gohmuri New Tata line, Jamshedpur, PS-Gohmuri, Dist East Singhbhum. I would like to inform you that today i.e. 24/02/22 at about 05:15 hrs on the way to returning home from Bumpur, when we reached near mekatala railway gate, suddenly our car (maruti-suzuki Ertiga) having Registration No - JH05 DC/6266 got skidded from the road and fell down in a ditch by the road side (Purulia - Barakar Road) due to rash and negligent driving of the driver of the vehicle.

There was other three persons namely ① Jasbir Singh S/O Lt. Gurmeet Singh ② Jagtar Singh S/O Chandan Singh ③ Raj Kumar S/O Ganesh saw in the vehicle and all got seriously injured. After the incident we shifted them to near by Narmardih Hospital were the on duty M.O. referred them to any higher center

① Balwinder Singh and ② Rani Kour succumbed to their injury. I am to inform you that we several time asked the accd. driver to slow down the vehicle as he was driving the car in excessive speed. Other two (2) persons namely ① Jasbir Singh and ② Jagtar Singh was ~~referred~~ ^{referred by} the released after primary treatment.

I, therefore, request you to take legal action against the accused driver and to cause and an investigation over the incident and oblige.
