I, Tapan Sen S/O- Paresh Chandra Sen residing at Vill-Dendua, PO+PS-Salanpur, Dist – Paschim Burdwan, W.B., am working as a supervisor under the contract of M/S UniTech at the site of Shakambhari Ispat & Power Ltd. Today i.e. on 11.02.2022 on Friday at around 09:55 A.M. inside the factory premises, due to reckless and carelessness driving of TATA Tipper (Hywa) driver having vehicle No- WB 45/0246, the vehicle has struck off one of our labour namely Rajesh Bauri S/O- Malin Bauri of Vill-Kalikend, PO-Manpura, PS-Adra, Dist-Purulia, W.B. working in the above said site who got seriously injured. After accident, he was taken to Harmadih Hospital where he was declared death on arrival by attending medical officer.

So, you are hereby requested to lodge a complaint against the above said driver & also do needful in this matter from your good end as you deem fit & fine these circumstances so that the victim's family can get fair & reasonable justice.
