with humble respect I beg to draw your kind notice that I am legally married wife of Sailendra Kumar son of Gopal Prasad Burnwal resident of stn no DS/40/B old colony, Near Masjid, Anara, Purulia and Permanent Address Vill & Post ps - Dumri, Dist - Giridih, Pin - 825106, 0

My Marriage was solemnised with Sailendra Kumar on 25.04.2018 at native place at "Ma Gayatri Singar Store" Ashram Road, New Barganda, Giridih, according to Hindu, rites and customs. After marriage I went to my in-law's house.

Since my marriage my in-laws members did not behave with me in good manner. My husband Sailendra Kumar is an employee of South Eastern Railway, Adra Division and presently he is posted at Adra Designated as Asst. Loco pilot, Adra being resident at Railway quarter at Anara, stn No. DS/40/B old colony, Near Masjid, Dist - Purulia.

I resided with my husband at the said stn and out of our said wed-lock one female child was born on 29.9.2019. My husband is a man of ill-tempered having no regard and good behaviour with me. He has got no culture and want of maintaining good relation with me.

During staying Anara my husband always tortured upon me physically and Mentally. He has got no love affection with his daughter. Most of the time my husband became furious and assaulted me by fists and blows and sometimes with other heavy articles.

Thereafter I was tolerate all his rude nature and behaviour but last on 17.01.2022 my husband severely assaulted me by first and blows at my ear and I was unconscious. on the next date I left my place of residence and take shelter at my sister house at Isri Bazar at parasnath. And thereafter I went to my paternal house and medically treated there.

My life is very danger stage. During this period my relatives attempted to compromise with him but no fruitful result at all. And it is not at all possible by me to live with my husband that I further stay with him than I will not save my life from my husband's such inhuman torture.

In the light of such circumstances I therefore pray before you please do the needful by taking proper legal steps against my husband Sailendra Kumar with immediate effects.
