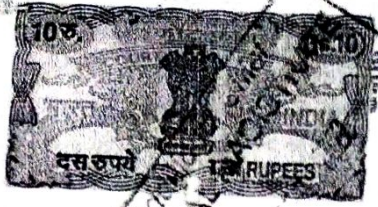

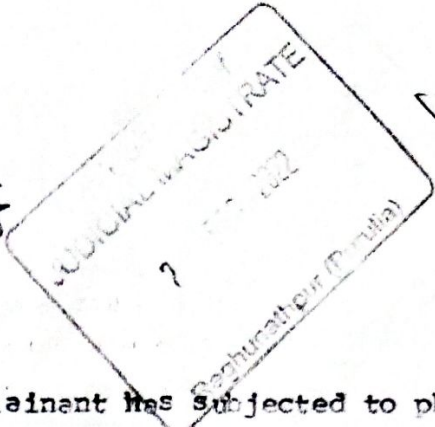

The complainant most respectfully beg to
state as follows:-

1. That the complainant is the legally married wife of the one accused person Md. Alauddin Ansari and their marriage was solemnised on 14-12-2018 according to Muslim rites, customs and usages as prevalent in their community in presence of the parents relative of both sides.
2. That at the time of the marriage between the complainant and the accused persons, it is pertinent to mention the family members of the complainant gave a cash of RS:-1,50,000/- (Rupees One lakhs and fifty thousand only) along with golden and silver ornaments, utensils etc. to the accused persons.
3. That since after marriage, the complainant went to her matrimonial home as usually and started to live with accused persons
4. That suddenly husband/one accused person of the complainant told the complainant to illegal demand of RS:- 50,000/- (Rupees Fifty thousand only) from her family for purchasing a Auto vehicle.
5. That the complainant informed the matter of her family member but parents of the complainant was unable to arrange said amount due to poverty.

6. That as a result the complainant has subjected to physically and mentally tortured by the husband/one accused person and his family in-mates.

7. That on 15-01-2022 the accused person/husband instigated by his family in-mates assaulted and ousted the complainant from her matrimonial home. Subsequently the complainant reached her father's house.

8. That the complainant went to Para Police Station on 19-01-22 to lodge the written complainant where the concerned police officer informed the complainant to take shelter of the court.

9. That finding no other alternative the complainant has to take shelter before the Ld. court for redressal of her grievances.

It is therefore prayed that your Honour may graciously be pleased to direct officer-in-charge, Para Police Station to register a complaint to treat the same as F.I.R. against the above named accused persons and other/others, direction/directions as your Honour may deem fit and proper.
