Sub: Initiation of necessary Criminal action against Sri Banerwar Mahato, Jeevika Sevak of Bhowridih GP for negligence of his duties.

Ref: Order dated 11/01/2022 passed in WPA 7388 of 2019 in Ramjan Mirdha vs. The State of West Bengal and subsequently letter received from Additional District Magistrate (General), Purulia vide memo no: 155/GP, dated. 02.02.2022.

With reference to the above-mentioned subject this is to inform you that Sri Banerwar Mahato, Jeevika Sevak of Bhowridih GP, was entrusted with the task of IAY Facilitator for Bhowridih GP, but due to negligence of his duty an amount of Rs 37500.00 and Rs 67500.00 were allowed in FY-2015-16 respectively in favour of Sarubala Kumbhakar, W/O- Durga Charan Kumbhakar of Vill+Po-Lipania, PS-Para, Dist-Purulia & Nuresha Bibi, W/O-Bakksu Ansari of Vill+PO-Lipania, PS-Para, Dist.-Purulia though previously they had got the benefits of Geetanjali Housing Scheme.

As per communication vide memo no: 143/BDO/Para dated. 31.01.2022, it is stated that the full amount i.e. Rs. 1,05,000 (One lakh five thousand) has been fully recovered from the two no of Beneficiaries.

With reference to the order dated 11/01/2022 passed by Prakash Shrivastava, Hon'ble C.J. and Rajarshi Bharadwaj, Hon'ble J. of Hon'ble Calcutta High Court in WPA No.7388 of 2019 Ramjan Mirdha-Vs- The State of West Bengal, the Court has directed that "The proceedings of the District Magistrate, Purulia dated 07.05.2018 have been placed on record wherein in internal page 3, he has found that the defalcation in respect of Geetanjali Scheme was done to the tune of 1,05,000/- out of which Rs. 54,000/- have been recovered. Once the finding of defalcation is recorded then the District Magistrate having due regard to the earlier order of the Division Bench of this Court was required to do the needful to initiate the criminal action."

I am directed to initiate the necessary criminal action against Sri Banerwar Mahato, Jeevika Sevak of Bhowridih GP, vide memo no: 155/GP, dated. 02/02/2022 issued by ADM(G), Purulia.
