Respected Sir,

In producing herewith one accd. person namely Sunil Dutta (50yrs) S/O- Sankar Dutta of Vill- Poradih PS-Puncha, District- Purulia with seizure of 15 pcs. Sealed bottles of Dil Khush country spirit containing 600 ml. each which were seized under proper seizure list.

I beg to submit that today (01.02.22) at 17:05 hrs while myself along with force were performing anticrime mobile duty near Poradih more . During mobile duty received source information that one Sunil Dutta (50yrs) S/O- Sankar Dutta of Vill- Poradih PS-Puncha, District- Purulia has illegally stocked liquor in his Hotel near Poradih more under PS- Puncha & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to the said place to work out the information. At 17:05 hrs after reaching near Poradih more held raid in the Hotel of Sunil Dutta (50yrs) S/O-Sanakar Dutta of Vill- Poradih PS-Puncha, District- Purulia and found that the above noted person was keeping / selling liquor which were kept in his Hotel, on demand Sunil Dutta failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also 15 pcs. Sealed bottles of Dil Khush country spirit containing 600 ml. each which were seized under proper seizure list duly signed by witnesses and labeled at the same and one of the same bottle is taken as sample which is sealed and labeled . During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee. I also issued check list U/S-41 (1)(a), (b) (I), (II) Cr.P.C. Direction of the Supreme Court of India vide Criminal Appeal No.-1277 of 2014, Spl. Leave

The arrested accd. Sunil Dutta (50yrs) S/O- Sankar Dutta of Vill- Poradih PS-Puncha , District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1) C/749- Jaladhar Koibarta, 2) C/752 Durjodan Sing Sardar both of Puncha PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against The arrested accd. Sunil Dutta (50yrs) S/O- Sankar Dutta of Vill- Poradih PS-Puncha, District- Purulia under proper section of law.
