Respected Sir,

In producing herewith one accd. person namely Amar Duary (35yrs) S/O- Lt. Niranjan Duary of Vill- Poradih PS-Puncha, District- Purulia with seizure of 18 pcs. Sealed bottles of Dil Khush country spirit containing 600 ml. each, which were seized under proper seizure list. I beg to submit that today (01.02.22) at 19:05 hrs while myself along with 1) C/1147 Bappaditya Nandi, 2) C/1228 Babulal Hansda both of Puncha PS were performing anticrime mobile duty near Tusugoria more. During mobile duty received source information that one Amar Duary (35yrs) S/O- Lt. Niranjan Duary of Vill- Poradih PS-Puncha, District- Purulia has illegally stocked liquor in his Hotel/shop at Tusugoria more under PS- Puncha & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to said place to work out the information. At 19:15 hrs after reaching Tusugoria more held raid in the Hotel/shop of Amar Duary(35yrs) S/O- Lt. Niranjan Duary of Vill- Poradih PS-Puncha, District- Purulia and found that the above noted person was keeping / selling liquor which were kept in his Hotel/shop, on demand Amar Duary failed to produce any valid documents in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested and also seized 18 pcs. Sealed bottles of Dil Khush country spirit containing 600 ml. each under proper seizure list duly signed by witnesses and labeled at the same and one of the same bottle is taken as sample which is sealed and labeled. During arrest the ground of arrest was duly notified, issued arrest memo and handed a copy of the same to arrestee. I also issued check list U/S-41 (a), Cr.P.C.

The arrested accd. Amar Duary (35yrs) S/O- Lt. Niranjan Duary of Vill- Poradih PS-Puncha , District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized

possession and sale of liquor.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against the arrested accd. Amar Duary (35yrs) S/O- Lt. Niranjan Duary of Vill-Poradih PS-Puncha, District-Purulia under proper section of law.
