Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Mihir Sing Sardar (30yrs) S/O- Lt. Ram Sing Sardar of Vill- Karmatard, PS-Puncha, District- Purulia with seizure of 12 ltrs ID liquor in a container which were seized under proper seizure list.

I beg to submit that today (18.02.22) at 17:05 hrs while myself along with force were performing anticrime mobile duty near Karmatard village. During mobile duty received source information that one Mihir Sing Sardar (30yrs) S/O- Lt. Ram Sing Sardar of Vill- Karmatard, PS-Puncha, District- Purulia has illegally stocked ID liquor in his house under PS- Puncha & selling the same. On receiving the information, I informed the matter to you and as per your instruction I along with force proceed to the said place to work out the information. At 17:25 hrs after reaching, held raid in the house of Mihir Sing Sardar (30yrs) S/O- Lt. Ram Sing Sardar of Vill- Karmatard, PS-Puncha, District- Purulia and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Mihir Sing Sardar failed to produce any valid documentary authority in respect of selling of ID liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also 12 ltrs ID liquor in a container out of which 300 ml. (approx) in a plastic bottle, which were seized under proper seizure list duly signed by witnesses and labelled at the same. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee. I also issued check list US-41 (1)(a), (b) (l). (II) Cr.P.C. Direction of the Supreme Court of India vide Criminal Appeal No.-1277 of 2014, Spl. Leave petition.

The arrested accd. Mihir Sing Sardar (30yrs) S/O- Lt. Ram Sing Sardar of Vill- Karmatard, PS-Puncha, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of ID liquor.

It may note here that during raid 1) C/749- Jaladhar Koibarta, 2) C/580 Pradip Kr Bag both of Puncha PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against The arrested accd. Mihir Sing Sardar (30yrs) S/O- Lt. Ram Sing Sardar of Vill- Karmatard, PS-Puncha, District- Purulia under proper section of law.
