In sending here with the original FIR copy, arrest memo, PR & Bail bond of accd. Pradip Mahato (18+ yrs), S/O- Shraban Mahato of vill:-Baligara, PS- Purulia (M), Dist-Purulia.

I beg to state that on 10.02.2022 at 11.15 hrs received a typed written complaint from PSI Sandip Pal of Puncha PS to the effect that on 10.02.2022 at 10:05 hrs during his special drive (MV Checking) he found one Motor Cycle rider namely Pradip Mahato (18+ yrs), S/O- Shraban Mahato of vill:-Baligara, PS- Purulia (M), Dist-Purulia with Motor Cycle No- WB56L-2766 was riding the said motor Cycle very rush and negligently with excessive speed and violating the on duty Police Signal at Kundhurka more under Puncha PS, on Tusugoria-Baragram pitch Road. Hence said rider was arrested and Motor Cycle along with RC and insurance certificate were seized, but the rider failed to produce any driving license. Over which above noted case has been started against the arrested accused person namely Pradip Mahato (18+ yrs), S/O- Shraban Mahato of vill:-Baligara, PS- Purulia (M), Dist-Purulia. O/C Puncha PS endorsed to me to investigate this case. Accordingly I SI Chandidas Chakraborty took up its investigation. As the offence is bailable hence accused rider namely Pradip Mahato was released on bail after executing proper bail bond & PR bond.

There after Shraban Mahato, S/O- Lt. Mariram Mahato of vill:-Baligara, PS- Purulia (M), Dist-Purulia came to PS and turned up surety for arrested accd person Pradip Mahato (18+ yrs), S/O- Shraban Mahato of vill:-Baligara, PS- Purulia (M), Dist-Purulia

Accordingly O/C Puncha PS released him on bail after furnishing proper bail bond and PR bond duly signed by him.

Under the above circumstances I pray before your kind honour that bail of above noted FIR named accd person may kindly be accepted and obliged.
