Most respectfully sheweth:-

- 1) That on 01.09.2021 at about 6.00 A.M. the complainant was at his paddy field within their village, Mouza- Sindurpur and he was busy with sprinkler irrigation system there at from a nearby pond and when he was trying to levelling a very high 'ail' cutting some earth from the portion of it for smooth passing of water by way of fixing a ladder over a hollow at the base of a large tree with help of necessary equipments, all the accused persons being armed with deadly

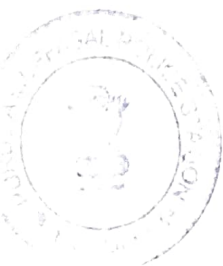

weapons like Lathi, iron rod etc. and forming an unlawful assembly²⁻² harrowed²⁻² your petitioner/ complainant and started hurling abusive language aiming at your petitioner and the accused no.1 all of a sudden with an intention to kill the complainant tried to inflict a blow on his head by a iron rod but the complainant very rapidly removed his head, but lost balance and fell down on the earth. Then the accused person no.1 assaulted your petitioner on his right chest with the help of his iron rod and the complainant received injury on his ribs. Then all the rest accused persons also started inflicting kicks, fists and blows upon the different part of the person of your petitioner.

- 2) That on receipt of such injuries your petitioner started groaning and hearing hue and cry the neighboring people started rushing to the place of occurrence and seeing them to come the accused persons²⁻² fled away, but at the time of their departure all the irrigation equipments such as irrigation pump and pipe, drip irrigation filters, water emitters, pipe connector fittings, hack saw etc. of your petitioner they took away.
- 3) That thereafter one of the nephew of your petitioner /complainant namely Khurshid Ansary took him firstly to Kustaur BPHC and there after he was referred to Deben Mahato (Sadar) Hospital/ Purulia Govt. Medical College & Hospital and got admitted their.
- 4) That the complainant thereafter being²⁻² ~~forced~~ ^{fit} to move had been to the Purulia (M) P.S. with a written complainant depicting inter alia all the real scenario what happened wrongfully upon him when the officer on duty asked him to him after puja vacation since they were busy with Law and order duty during such prevailing festive atmosphere. But even after completion of puja vacation though your petitioner had been to P.S. time and again for having proper legal relief he was never permitted to meet ²⁻² ~~the~~ ^{him} I/C of the concerned P.S. and the officer on duty rather declined to accept his letter of complaint.
- 5) That your petitioner then sent his letter of complaint under registered cover with A/D addressing the I/C Purulia (M) P.S. but then too no step was taken towards institution of any specific case so that the accused persons be prosecuted and punished.

- 6) That due to such inaction on the part of the police personnel of the concerned P.S. your petitioner informed the matter in writing ^{on 10.12.2021} before S.P Purulia on 10.12.2021, but unfortunately the District Police Administration still turned deaf ears to the same and no specific case has yet been instituted.
- 7) That search and seizure is very much warranted in the instant case and your petitioner is a very ^{poor} poor and rustic person heaving no such annual income for incurring expenses of a complaint case.

In light of the above it is therefore prayed that Your Honour may graciously be pleased to forward the instant petition of complaint to the Inspector in charge of Purulia (M) P.S. with a direction upon him to investigate into the case treating the same as F.I.R under the provisions ^{of Cr.P Code} contemplated under sections 156 (3) Cr.P Code.
