No 353/22 Dt. 01.02.2022 and GDE No 16 Dtd. 01.02.2022. During my mobile duty, I received a secret tip off that an illegal possession of huge quantity of Country spirit. Subsequently, Uniformed you and as per your direction, I rushed to the spot that is Mishra Shop at Bhangra (Bye pass road towards Chharrah Aerodrum) and after arriving at the spot and as per your instruction conducted raid in the shop (Mishra Shop) of Chandi Mishra under this PS at about 12:25 hrs. During the raid 4/5 persons fled away near the shop and detained 02 (two) persons. On asking the identity they disclosed their name address as noted supra.
