Sub: **Complaint against** Chandi Mishra & Narugopal Mondal .

Sir,

In producing herewith 02 (two) arrested accd. persons namely (i) Chandi Mishra (42 yrs) s/o Lt. Chhutulal Mishra of Vill- Bhangra (Mishra Para), PS- Purulia (M), Dist- Purulia & (ii) Narugopal Mondal (41 yrs) S/O Lt. Ramanath Mondal of Vill-Sonajuri, PS- Kashipur, Dist- Purulia with seizure list and seized articles.

I beg to submit that today (01.02.2022) while I was detailed to perform Spl. mobile duty in PS area along with force i) C/624 Pradip Chakraborty & ii) C/2734 Susanta Panda both are Purulia (M) PS & Purulia (M) PS C.C. No 353/22 Dt. 01.02.2022 and GDE No 16 Dtd. 01.02.2022. During my mobile duty, I received a secret tip off that an illegal possession of huge quantity of Country spirit. Subsequently, I informed you and as per your direction, I rushed to the spot that is Mishra Shop at Bhangra (Bye pass road towards Chharrah Aerodrum) and after arriving at the spot and as per your instruction conducted raid in the shop (Mishra Shop) of Chandi Mishra under this PS at about 12:25 hrs. During the raid 4/5 persons fled away near the shop and detained 02 (two) persons. On asking the identity they disclosed their name address as noted supra. On interrogation they confessed that they jointly procured and stock the Country spirit for selling illegally from this shop so that they could gain more amount from the selling of (liquors) Country Spirit. On demand they failed to produce any valid document in respect of selling and possession of said (liquors) Country Spirit at this shop. Subsequently, I seized 22 (twenty two) sealed bottles Dil Khush country sprite each containing 600 ml. containing one plastic bag. In which kept 01 sealed bottles as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused persons. Consequently, I arrested the above noted accused persons after informing them the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused persons.

The above noted arrested persons namely (i) Chandi Mishra (42 yrs) s/o Lt. Chhutulal Mishra of Vill- Bhangra (Mishra Para), PS- Purulia (M), Dist- Purulia & (ii) Narugopal Mondal (41 yrs) S/O Lt. Ramanath Mondal of Vill-Sonajuri, PS- Kashipur, Dist- Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from this shop. Under the fact and circumstance kindly take necessary lawful action against (i) Chandi Mishra (42 yrs) s/o Lt. Chhutulal Mishra of Vill- Bhangra (Mishra Para), PS- Purulia (M), Dist- Purulia & (ii) Narugopal Mondal (41 yrs) S/O Lt. Ramanath Mondal of Vill-Sonajuri, PS- Kashipur, Dist- Purulia
