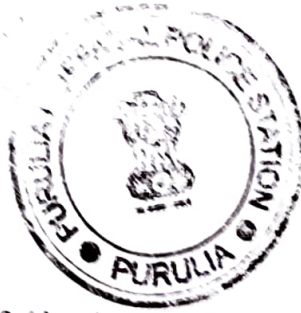

In producing herewith 03 (three) accused persons namely (i) Durgadas Bouri (26 yrs) S/O Nimai Bouri of Vill- Lagda, PS- Purulia (M), Dist- Purulia, (ii) Padam Bahadur (33 yrs) S/O Damar Bahadur of Vill- Chakjharia, PO- Nadiara, PS- Purulia (M), Dist- Purulia & (iii) Mansu Roy (40 yrs) S/O Lt. Saman Roy of Raibaghini, PS- Purulia (M), Dist- Purulia. I beg to submit that today (01.02.2022) at 17:40 hrs. in course of my anticrime patrolling duty while I along with (i) C/611 Jitendranath Pathak, (ii) C/683 Mansaram Rajak & (iii) C/321 Tulsidas Roy all of Purulia (M) PS reached at Lagda Morh along Purulia-Ranchi Road (NH-32) and found 5 / 7 persons are obstructing on road Trucks, medium vehicles, etc and demanding money as subscription from the drivers of the vehicles forcibly and dishonestly and under threatening. Resulting said road became inconvenience to others vehicular traffic. On seeing I along with force approached before the collectors and on seeing Police Party they started to run away. We apprehended 03 (three) persons. On investigation they disclosed their name and address as noted above and also stated that they were collecting money from on road trucks and other vehicles for celebration of 'Saraswati Puja. They also issued receipts, in which it is printed 'Joy Mahakal Club Chalkjharia, Purulia'. Collection of money under threat and by obstructing the normal movement of a person or traffic falls under preview of 384 IPC and by doing this act the apprehended persons have done the offence on that section of law. The illegal act has been informed to these three apprehended persons and they have been taken into custody by issuing arrest and inspection memo on the spot. Subsequently myself seized the subscription book from Durgadas Bouri (26 yrs) S/O Nimai Bouri of Vill- Lagda, PS- Purulia (M), Dist- Purulia and on search of the person handed over amount of Rs- 360/- as collection of subscription which seized with proper seizure list duly signed by the person from whom seized and the witnesses. On further search no other amount was found except wearing apparel and some personal belongings.

On the above circumstances a specific case u/s 384/34 IPC may kindly be initiated against the 03 (three) arrested person and two / three others and may be arranged for its investigation.
