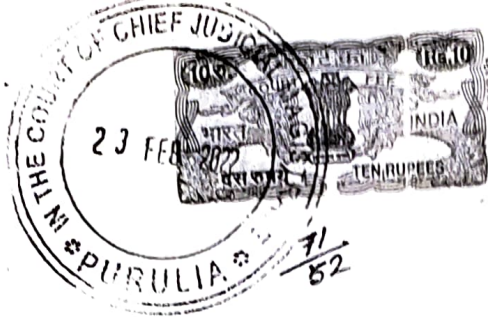

She went there and tried to resque her father. At that time said Falguni Gope assuauated her by SABAL at ner waist region. Her mother was assaulted by th them.
3. That the petitioner sustained injury and admitted at Purulia sadar Hospital. She was treated there. The petitioner was discharged on 22.1.22.
3. That the matter was reported on the date of inciient to police station and no action was taken. The petitioner lodged the written complain to S.P. PURULIA on 25.1.22.
4. That now the complainant has been compelled to file this case before your Honour.

That no case has been started by the police till now.
