

I, Prashant Kishor (AE&SM), along with Sri Suraj Today, i.e. on 08.02.2022 Kumbhakar, JE (Gr-ii), Sri Deb dulal Banerjee, Sr. TSH of Telkalpara CCC, WBSEDCL conducted a raid programme at village Uporpindra under Purulia (M) P.S. When our team at about 02.20 P.M.. entered to the Domestic premises of Harinarayan Pathak, we found that he was enjoying electricity dishonestly by means of direct hooking from nearest L.T.O.H line and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized, and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 02.35 P.M.. after completion of inspection & necessary formalities.
