Respected Sir,

In producing herewith three seized vehicles (Tractors) (i) R.C No-WB55A-6750, Engine No. E3401123, Chassis No. T053357609GF (Blue) (ii) R.C No-WB55B-0832, Engine No. S325J97898, (iii) R.C No-WB55B-1981, Engine No- RJJ4YBA5263, Chassis No. 05552117R1 attached with its loaded Sand Trolley and with proper Seizure list.

The nub of the fact in a nutshell is that on 13.02.2022 at 17.55 hrs while myself along with force 1) C/768 Ajit Murmu, 2) C/1350 Subodh Bauri all of Purulia (M) PS left the PS for performing Spl. raid duty vide Purulia (M) PS CC No 464/2022 and GDE No 547 Dt. 13.02.2022 in PS area. During my mobile duty, I received a tip off at 18:35 hrs that three tractor driver & its owner were lifting sand illegally from Kansai river bed and said suspicious tractors loaded with sand at Tento ghat. Subsequently, I along with force proceeded towards Tentlo ghat to work out the tip off. While I along with force arrived at Tentlo ghat and found that 03 (Three) tractors loaded with sand and ready to move. on being see the police party from far away, the drivers of the said vehicles (Tractor) fled away to avoid the any touch of police. I along with force also chased the driver to detain but could not. Then I along with force intercepted the vehicles (Tractors) (i) RC. No-WB55A-6750, Engine No. E3401123, Chassis No. T053357609GF (Blue) (ii) RC No-WB55B-0832, Engine No. S325J97898, (iii) R.C No-WB55B-1981, Engine No- RJJ4YBA5263, Chassis No. 05552117R1 attached with its Trolley loaded with Sand at 19:15 hrs and I found the vehicles as well as goods as identical as I received prior information. I also informed the matter to my I/C Purulia (M) PS and as per his kind direction, I along with force were awaiting long time but none could turn up before me. It was ascertained that the driver of the those tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and he have been running a clandestine business. So it is reasoned to belief that drivers of the said vehicles in cahoots with the owner of the vehicle procured the said sand form Kansai River at Tentlo ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the (Tractors) (i) RC. No-WB55A-6750, Engine No. E3401123, Chassis No. T053357609GF (Blue) (ii) RC No-WB55B-0832, Engine No. S325J97898, (iii) R.C No- WB55B-1981, Engine No- RJJ4YBA5263, Chassis No. 05552117R1 attached with Trolley loaded with Sand approx. 300 Cft. under proper seizure list. Thereafter, I brought the seized tractors with sand loaded trolley to Purulia (M) PS compound as per kind direction of I/C Purulia (M) PS.

Under the above facts and circumstances kindly take lawful action against the drivers as well as owners of the vehicle (Tractors) (i) RC. No-WB55A-6750, Engine No. E3401123, Chassis No. T053357609GF (Blue) (ii) RC No-WB55B-0832, Engine No. S325J97898, (iii) R.C No-WB55B-1981, Engine No- RJJ4YBA5263, Chassis No. 05552117R1 (Red)
