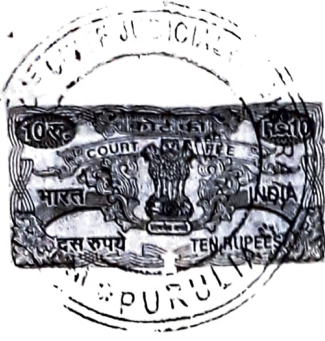

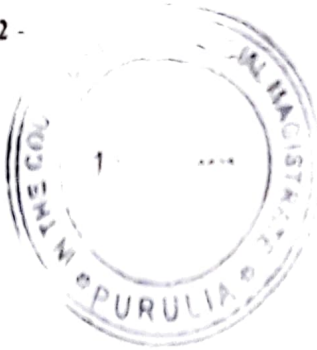

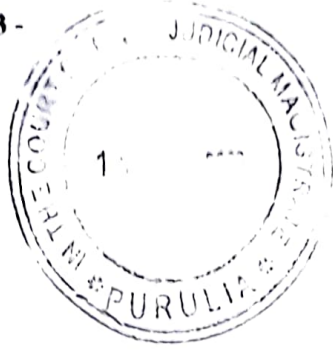

**Most respectfully begs to state:-**

1. That the complainant is the registered owner of the vehicle being Registration No. JH-10BN/9400 and he used to ply his vehicle on hire basis to various customer including various transporters for carrying various goods / articles.
2. That the aforesaid vehicle of the complainant was hired by Harsh Transport Co. of Transport Nagar, Shop No. 52, Singrauli, M.P for a consignment from Sendoz Impex Ltd. CIC Steel Pvt. Ltd. to CIC Steels Pvt. Ltd, within P.S- Borjora, Dist- Bankura, by loading coal weighing about 25.190 MT on 10.12.2021 vide Consignment No. 2681, and the driver of the vehicle at the relevant date and time was Mithilesh Yadav, S/o- Sadanand Yadav @ Sadhu Yadav, a resident of Vill- Mothra, P.S- Gangta, Dist- Munger.
3. That the vehicle of the complainant was departed on 10.12.2021 after loading the coal as per consignment from Singrauli and the destination was Borjora, within the district Bankura, West Bengal. During journey as per last GPS location it was found that the vehicle was at Gengara, within Purulia (M) P.S Dist- Purulia, PIN- 723148 on 12.12.2021 at about 12.05 A.M.
4. That thereafter, the complainant was eagerly waiting for his said vehicle, but after lapse of considerable period as the vehicle was not reached at the destination, he tried his level best to contact with the driver of the vehicle namely Mithilesh Yadav, but could not be able to contact with him. After that the complainant also tried to search his vehicle but uptill now, the complainant could not be succeeded.
5. *That be it mention here that all the original vehicular documents are lying in the vehicle.*

6. Under the circumstances the complainant have every doubt that his aforesaid driver in collusion with other by hatching a conspiracy, stolen away my above mentioned vehicle along with the loaded coal for his wrongful gain.
7. That the above mentioned matter was duly intimated to the Officer-in-charge of Purulia (M) P.S as the last location of the said vehicle was found at Gengara, within Purulia (M) P.S and within the jurisdiction of this Ld. Court, but the police of Purulia (M) P.S. refused to accept the same, the reason is best known to them, thereafter the said complaint was send to The Inspector-in-charge of Purulia (M) P.S through registered post on 07.01,2022, but till date no action has been taken.
8. That subsequently, the Complainant on 11.01.2022 informed the matter to the Superintendent of Police, Purulia but even then as no step has been taken against the Accused Persons by the police, the Complainant is being compelled to lodged this Petition u/s 156 (3) Cr.P.C. before Your Honour's Court.

It is therefore prayed that your Honour will be graciously pleased to send this petition to Inspector-in-charge of Purulia (M) P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to investigate the case in accordance with law and to unearth the wrongdoer
