In producing herewith 01 (one) seized vehicles (Tractors) having Reg. No WB55E-2880, Eng. No D61251 & Chassis No. 4261264 attached with its loaded Sand Trolley and with proper Seizure list.

The nub of the fact in a nutshell is that on 18.02.2022 at 09:15 hrs while myself along with force 1) C/06 Debdas Mukherjee & 2) C/768 Ajit Murmu both of Purulia (M) PS left the PS for performing Spl. mobile duty vide Purulia (M) PS CC No 602/22 and GDE No 758 Dt. 18.02.2022 in PS area.
