Sub:- FIR against some unknown miscreants in connection with Raid duty (Minor Minerals)

On specific source information, the ADM and DL&LRO, Purulia instruct me to conduct a Raid (Minor Minerals) urgently. I, Sri Moral Hembrom S/o Sailendranath Hembrom, (Designation) O/C Mines along with team members Viz: 1) Sanjay Karmakar, Head Clerk 2) Amit Kr Sao, U.D.C, 3) Pawan Kr. Paswan, Gr-D, went to the spot at about 11.45 am on 09.02.2022. i.e. at Mahato Para near Telkalpara Smashan Kali Mandir.

After reaching the Telkalpara we observe that JCB Machine having no JH05AZ5885 were extracting Earth (Morrum) without prior permission from the appropriate authority, and transporting the same in tractors having no JH 09AG6886 and others for filling-up nearby land inside of Hotel Sagar Raj Resort.

On demand of valid challans in connection with Royalty of Morrum, the owner of tractor driver and others were started using slang languages towards my team. On demand of Penalty of Minor Minerals, Tractor drivers, tractor owners and JCB owners were just beating with **Lathi / Danda**. They also loudly announce that they never paid Govt. Royalty, Vehicle Tax, and others. No body can hamper their business. They are the hero of that place.

Hence, the tractors owners were obstructing public service in discharging of Public function by physical hackle and by beating us to demoralize my team members. Therefore I request you to kind treat this as First Information Report U/s 21 MMDR Act 1957 and others.
