With due respect I would like to lodge this complaint against my husband namely Sri Vishal Agarwal S/O Sri Anand Agarwal , his father sri Anand Agarwal S/O late Sunderlal Agarwal , his mother Mrs. Asha Agarwal W/O Sri Anand Agarwal , brother Amit Agarwal S/O Sri Anand Agarwal, Mrs. Suman Agarwal W/O Sri Amit Agarwal , another brother Vaibhav Agarwal S/O Sri Anand Agarwal ,Mrs. Heena Agarwal W/O Sri Vaibhav Agarwal all residents of Aster Tower flat no. B 1001 10th. floor and B 1403 14th. floor Vasant Valley, Opp. Oberoi Mall, near Dindoshi fire station, P.O. Shiv Sagar building Dhobi ghat Malad (east), P.S. Shantaram Talav, Kurar, Ambewadi, Malad (east) and/or behind Sai Baba Mandir, Shantivan Society, Malad (east) Mumbai-400097 to the effect that I am a divorcee and Vishal Agarwal with whom my marriage was held was a widower and my marriage was solemnised on 24th. April 2017 with Vishal Agarwal and the marriage was registered under the Hindu Marriage registration act on 02nd November 2017 at Purulia with sri Vishal Agarwal widower and I was divorcee at the time of marriage and at the time of marriage sufficient Dowry in cash, Gold ornaments, Diamond ornaments and Silver utensils etc. etc. were given as per their demand . The list of which will be supplied later on. Thereafter I had been to my in-laws house with my daughter Palak at the address mentioned above at Mumbai.

It is also pertinent to mention in this juncture that whenever my husband came to Purulia for taking me on that particular occasion my husband abused me with filthy languages and when I protest the same then my husband physically assaulted me in presence of my family members and after intervening of my family members my husband Sri Vishal cool down but he demanded more dowry from my father and after receiving assurance from my father to pay in future he took me with him for my matrimonial home.

Since after marriage where my father in law, mother in law being provoked by brothers in law Sri Amit with his wife Suman and Vaibhav along with his wife Heena insisted me severally time and again through my husband Vishal Agarwal to bring more Dowry as the Dowry given at the time of negotiation and finalisation of marriage at Purulia was insufficient . Few months after the

marriage they started torturing and abusing me to bring more Dowry from my father . On refusal and or denial to fulfil their unlawful demand by my father because at present he is not in a position to give more Dowry of Rs. 10 lacs as demanded by my husband Vishal along with his parents, brothers and their wives assaulted and beaten me by catching & holding my hairs, fist and blow on my belly so many occasions/several times and sometimes they locked me in room and did not allow me proper food even refused to allow treatment of a Doctor. Being aggrieved my father came to my in-laws house and expressed with folded hands showing his inability to fulfil their illegal demands of Dowry at that moment and promise to pay in near future but without realising his inability they abused my father with a comment that they will not keep me in peace till they do not get the Dowry as demanded and they kept torturing upon me again and again both mentally and physically .

I had been driven out from in-laws house and they snatched my all belongings i.e. STRIDHAN and any how I have taken shelter under the umbrella of my parents house. Myself and my parents tried to negotiate the matter several times orally over telephone and in other ways but without any fruitful result rather all the persons named above threat me to face dire consequences and told do whatever I like. Be it further mentioned that all the above named persons have committed various type of offences with me with common intention.

I shall highly be obliged for your kind and sympathetic action in this matter at early date.
