In producing herewith one arrested accd. person namely Jagannath @ Bubai Gorain (30 yrs) S/O Lt. Magan Gorain of Vill- Bhabanipur, P.S Purulia (M), Dist.- Purulia with seizure list and seized articles.

I beg to submit that on 17.02.2022 while I was detailed to perform evening & Night mobile duty in PS area along with force i) C/624 Pradip Chakraborty, (ii) C/768 Ajit Kr. Murmu & (iii) C/2735 Soumen Nayak all of Purulia (M) PS & Purulia (M) PS C.C. No. 591/2022, Dt. 17.02.2022 and GDE No. 731 Dtd. 17.02.2022. During my mobile duty, I received a secret tip off that an illegal possession of huge quantity of Country spirit at Bhul village. Subsequently, I informed you and as per your direction, I rushed to the spot at Bhabanipur village and after arriving at the spot and as per your instruction conducted raid in the house of Jagannath @ Bubai Gorain of Bhabanipur village under this PS at about 06:05 hrs on 18.02.2022. During the raid 2/3 persons fled away in the house and detained one person. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he procured and stock the Country spirit for selling illegally from his house. So that he could gain more amount from the selling of (liquors) Country Spirit. On demand he failed to produce any valid document in respect of selling and possession of said (liquors) Country Spirit in his house. Subsequently, I seized 40 (Forty) sealed bottles Dil Khush country sprite each containing 600 ml. In which kept 01 sealed bottles (Dilkush) as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person Namely person namely Jagannath @ Bubai Gorain (30 yrs) S/O Lt. Magan Gorain of Vill- Bhabanipur, P.S Purulia (M), Dist.- Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his house.
