Sub : Prayer for lodging FIR against accused Gopal Kumbhakar (44), S/O Lt Rampada Kumbhakar of Ichhar, PS-Santaldih, Dist- Purulia, U/S 46 A (c) Bengal Excise Act, 1909.

Sir,

In producing herewith one arrested accused person named as Gopal Kumbhakar (44), S/O Lt Rampada Kumbhakar of Ichhar, PS-Santaldih, Dist- Purulia along with seizure - list and seized items as described below, I beg to state that on 18.02.2022 at about 06.35 hrs I received a source information to the effect that the country spirit, styled as 'Dil Khus' has been kept at Ichhar village under Santaldih PS in the house of above noted accused illegally, with an object to sale. I informed the matter to I.C. Santaldih PS and as per order of I.C Santaldih P.S. I along with force left for Ichhar village to work out the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the house of Gopal Kumbhakar at Ichhar village at about 06.55 hours. Seeing police party some unknown persons in front of the house of Gopal Kumbhakar were fled away. However, I could detain one among of them and asked about his identity. He revealed his name and identify as above and as well as admitted that he gathered the country spirit, styled as 'Dil Khus' for selling and he was the owner of the said house. However, I along with said accused started a search inside the house of Gopal Kumbhakar and found the following item in the said house -

1) 16 (Sixteen) bottles 80UP country spirit, styled as 'Dil Khus' each bottles containing 600 ML market value of each being in total approx Rs. 800/- (Eight Hundred only).

01 (one) bottle of 600 ML taken (Dil Khus) out of the above as sample packet, labeled and sealed with sealing wax.

2) Sale Proceed cash of Rs.- 90/- (Ninety only)

I interrogated him about the purpose of the stocking and possessing country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 07.05 hrs and 07.25 hrs & took up one bottle of each brand as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the country spirit illegally without any valid papers in his house has prima-facie been made out and for the interest of proper investigation, I arrested the above accused at 07.35 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused Gopal Kumbhakar (44), S/O Lt Rampada Kumbhakar of Ichhar, PS-Santaldih, Dist-Purulia.
