In producing herewith the one seized vehicle (Blue colour tractor with trolley loaded with sand) Having Eng No.- 3100DL53H510730F3 & Chassis No: JZQSU515311SM, attached with Seizure List. The nub of the fact in a nutshell is that today (17.02.2022) while I, along with C/67 Palash Patra & C/1457 Nityaranjan Rajwar, left Santaldih P.S. to perform evening mobile duty vide Santaldih PS GDE no. 690, dated 17.02.2022, in Santaldih PS area. During my evening mobile duty I, received a tip off at 19:05 hrs that, on the bank of the Damodar river bank (Ichhar Nadi Ghat) at Ichhar village under Santaldih PS, some persons were illegally lifting sand from the river transporting the same by a suspicious tractor to run clandestine business. Subsequently, I along with force proceeded toward Gowai river bank to work out the tip off. While, I along with force arrived near Damodar river bank (Ichhar Nadi Ghat) at Ichhar village under Santaldih PS and found that, some persons are illegally lifting sand in to a tractor attached with trolley.

I, along with force proceeded to intercept the vehicle and reached at the spot at 19.25 hrs but seeing the police persons the driver and others left the Blue Colour Tractor without any number plate having Eng No- 3100DL53H510730F3 & Chassis No: JZQSU515311SM, attached with trolley loaded with sand and fled away. I tried to find out the name & address of the driver and owner of the tractor but in vain.

During enquiry, it is ascertain that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business by transporting the same at Jharkhand State. So, it is reason to believe that they in cahoots with the owner of the vehicle procured the said sand from Damodar river bank (Ichhar Nadi Ghat) at Ichhar village side, by fraudulently means or theft by any means for transporting the same at Jharkhand State to run clandestine business. As per source information, they are habitual offender of this crime, as they have been engaged in the said illegal sand leafing business since long, behind the eyes of the administration.

So, I seized the said blue colour tractor without any registration number plate, having Eng No-3100DL53H510730F3 & Chassis No: JZQSU515311SM, attached with the trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter, I brought the seized tractor to Santaldih PS.

Under above fact and circumstances kindly take lawful action against the Owner & Driver of the above noted without number plate vehicle having Eng No- 3100DL53H510730F3 & Chassis No: JZQSU515311SM, as they committed offence U/S 379/411/413/414/120B IPC and 21(i)(4) of Mines and Minerals (R&D) Act – 1995.
