Sir,

In producing herewith one seized vehicle i.e. Tractor Mahindra B 275 DI bearing Reg. Number-WB 55A 0527, & having Chassis No- RAM00409MC fitted with Trolley loaded with sand. The fact of the case in brief is that on 19/02/2022 I, PSI Mrinmay Bhakta of Santuri P.S along with force were on mobile duty. During mobile duty on 19/02/2022 at about 18:15 hrs received credible source information that one Tractor is coming from Mohanpur Village side under Santuri PS loaded with sand. After receiving this information we were proceeding towards Mohanpur Village to work out the information. When we reached near Mohanpur Village, found that one Tractor is coming from Mohanpur Village side loaded with sand (Approx. 100 cft). On seeing the Police party the driver was trying to flee away. But after a hot chase, we could be able to detain the driver of said vehicle having No- WB 55A 0527. I asked the driver namely Parimal Mandal (36 yrs), S/O Lt. Manik Mandal, Vill.- Ghoramurga, P.S.- Santuri, Dist.- Purulia to produce valid documents in respect of said loaded sand but he failed to produce any valid documents in respect of loaded sand in the tractor as well as the valid documents in respect of that tractor but nothing found. Hence I seized the Tractor Mahindra B 275 DI bearing Reg. Number-WB 55A 0527, & having Chassis No- RAM00409MC fitted with Trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter I brought the said tractor as well as driver of the said Tractor to Santuri P.S. As such there is every reason to believe that the driver and owner of the Tractor Mahindra B 275 DI bearing Reg. Number-WB 55A 0527, & having Chassis No- RAM00409MC fitted with Trolley with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of Tractor Mahindra B 275 DI bearing Reg. Number-WB 55A 0527, & having Chassis No- RAM00409MC fitted with Trolley may kindly be started and arrange for its investigation.
