

I, Sandeep Saraf S/o Sri Shankar Lal Saraf residence at Sitaram Marwari Lane , Telkalpara, Purulia, Ward No 11, under P.S Purulia town Dist Purulia, Proprietor of Sandeep Enterprises AETC, Dulmi Under P.S Tamna Thanna would like to lodge the information to the effect that on 13/02/2022 at about 9.20 P.M a vehicle bearing Registration No. NL01 AD/1722 loaded with heavy iron Double Girder Cabin Operated EOT Crane was proceeding towards Purulia side from Tata Side on along Tata-Purulia (NH-32) Pitch Road in a high speed and in rash and negligent manner and when it reached near my Pollution Testing Centre Premises, at Dulmi Under Tamna P.S, suddenly the driver of the vehicle tried to turn the vehicle in a high speed and dashed the building wall of my A.ETC as result of which the building wall had broken and two of my labours namely Mathur Ansari S/O late Ananda Ansari, Village - Simulia, P.S Tamna, Dist- Purulia and his wife Akrun Nisha received sustained multiple grievous injuries on their person and further they were shifted to Purulia Sadar Hospital for their necessary treatment and various machineries including Pollution Testing Equipments were badly damaged cause huge loss to my firm for damager.

Under the circumstances, you are requested to take appropriate action as per law against the driver of the vehicle who was driving the said vehicle in a Rash and negligent manner .

It is to be mentioned here that due to taking treatment of injured labours and repairing the damaged goods /Property I could not submit the written compliant within time .


