



1. That the complainant is residing at her paternal home at Adra Panchudanga Churimahalla under P.S. Adra, Dist:- Purulia (W.B) within the local limit and jurisdiction of this court.
2. That the complainant married to Maz Ahamed Khan S/O Lt. Abdul Sattar Khan in the year 2005 according to Muslim rite customs and usage prevalent in their community, and out of their wedlock they blessed one son and one daughter.
3. That the accd. person is found actue change in his mind from the year 2008, when the complainants body was deteriorated due to birth of her daughter. He started torture physically and mentally upon the complainant in a filimsy reason.
4. That the accd. person abused the complainant in such a languages which cannot be narrated. The accd. assaulted the complainant with fist and blow, if she raise objection against any ill- act or misbehaviour.
5. That the complainant is to tolerate all the problems for a hope that the accd. would change his behaviour in future but the accd. person's behaviour is continuing in severe manner. After taking alcohol or sometime using narcotic (एक्सी) the accd. coming home at night committed torture physically and harrassed sexually without caring the health condition of the complainant.
6. That in the last week o f january 2022 the accd. person forcefully was trying to put the complainant signature on a blank paper with an intention to get prepared a suicide note but the complainant did not agree to put her signature on the

same. So the accd. person beat her and snatched her mobile and complainant was locked in a room.

7. That the accd. person's conduct is really a criminal minded. A criminal case is going on against the accd. person vide S.R. case no:242/2004.in Ragnunathpur court.

It is also noted that the complainant is the third wife of the accd. person.

8. That on 03-02-2012 at about 5/6 P.M. the accd. person again came home and forced the complainant to put her signature on a blank paper and on because the accd. became furious and beat her, abusing every language thereafter the accd. person snatched the mobile and the complainant and the accd. drove away the complainant from his house.

9. That the complainant reported the matter against the ill-act of the accd. before the T/S Adra P.S. by a written complaint and thereafter a written complaint is also sent through the Regd. Post on 08-02-22, to the S.D.P.O. Ragnunathpur and S.P. Purulia, but till date no legal action has been initiated against the accd. person, as accd. person is loitering in the locality disclosing that no one can do anything against him due to his ill-act.

10. That from the foregoing narrar it is crystal clear that the accd. person has committed an offence U/S 323/498(A)/506 I.P.C.
