

2. That R.S.plot No.2319 of mouza- Jorisha appertaining to Hal Tasdik khata No. 110 which was purchased by the predecessors of the complainant namely Patal Mahato and Surat Mahato both are S/o. Late Balei Mahato vide Reg. Sale Deed No. 2748 for the year 1980 dtd. 10.04.1980 with specific boundary the purchased area 50 dec.
3. That since after purchase aforesaid Surat Mahato and Patal Mahato had been possessing the same by transplanting huge number of trees such as Mango, Blackberry(Jam), Chnarah, Nim, Palash, Ankhra etc. and enjoying the usufruct there from.
4. That after demise of said Patal Mahato his son i.e. the present complainant also transplanted various trees thereon which are nicely grownup.
5. That on 07.01.2022 at about 10'00 A.M the accused person names above without having any right, title, interest or possession whatsoever over the purchased property of said Patal Mahato and Surat Mahato illegally trespassed into the said land and forcibly cut down one Mango tree, one chharrha tree, three palash trees and loaded on a tractor and fled away with the loaded tractor the complainant raised protest against the illegal act of the accused persons at that time the accused persons abused the complainant with filthy languages and threatened the complainant with dire consequences. The accused persons by this way committed theft of the trees standing over the land of the complainant due to which the complainant sustained a monetary loss of Rs. 10,000/- (Rs. ten thousand only).
