

Bhunia, O/C Arsha PS received an information today (04.03.22) at 06.15 hrs that some persons have pasted leaflets in the village area of Puara, Chatuhansa, G.P area under P.S Arsha in the last night to facilitate CPI Maoist movement and urging people to organize anti government movement after making criminal conspiracy. I diarized the information vide Arsha P.S G.D.E No- 124 dated-04.03.22 and accordingly informed my superiors and as per their direction myself along with night mobile officer ASI Tapan Kumar Mahato and force of Arsha PS with Govt. Vehicle No WB-68X/2741 left for those places to work out the information. At about 07.05 hrs on 04.03.22 we reached at Kantadih Hattola and found leaflets were pasted at the wall of shop of Raju Majhi. I seized the leaflets 03 Nos. from that place. After that I seized leaflets 02 Nos. from that place. The contents of all the leaflets are same as above.

Thereafter I went to Kumirdiha More at about 08.25 hrs and found 03 leaflets pasted on the wall of pan shop of Gulan Mandi. After that I seized leaflets 03 Nos. from that place. The contents of all the leaflets are same as above. From there I went to Radhanagar village at about 09.05 and found same poster were found in the football ground, I again seized the leaflets nos. 04 from the above place. From there I went to Sindurpur village at about 09.45 hrs and found some leaflets pasted on the wall of Sindurpur Pry School. After that I seized leaflets 03 Nos. from that place. Thereafter I went to Rajpati village at about 10.20 hrs and found some leaflets pasted on the wall of aTea shop of Sushil Modak. After that I seized leaflets 03 Nos. from that place.

I took photograph of each and every leaflet before seizure. All leaflets are written in Bengali script. All the seizures were duly signed by my accompanying officer and force as seizure witnesses and duly labeled separately. This is to be noted that since the contents of the leaflets are related to CPI Maoist no local person agreed to give signature on seizure list as seizure witnesses in fear as the area was highly LWE affected in the past.

From the above such leaflets it was clearly indicated that the miscreants created a group and with criminal conspiracy collected leaflets and make them prepared for the assigned work as well as engaged themselves in waging war against the State knowing it fully well and there by committed an offence u/s-121/121A/124A/120B IPC.

So we started interrogating different villagers from where the leaflets were found. We searched other adjoining villages also but did not found any other leaflets, posters etc.

Our source informed that the miscreants are may be their respected houses. We searched the house of the above notes accused at their houses and able to arrest all of them namely (1) Mantulal Sahis S/O Lt. Sufal Sahis of Rajpati, PS- Arsha, Dist- Purulia (2) Sarada Prasad Soren S/O Lt. Paban Soren of Mahultanr, PS- Arsha, Dist-Purulia (3) Manindranath Majhi S/O Maha Majhi of Mahultanr, PS- Arsha, Dist-Purulia (4) Rohin Kumar S/O Rampada Kumar of Satra, PS- Arsha, Dist- Purulia (5) Padak Kumar S/O Ghenaram Kumar of Sindurpur, PS- Arsha, Dist-Purulia (6) Ratan Ch. Gope S/O Lt. I interrogated them, during interrogation they confessed their guilt and stated that they had printed those leaflets from the computer shop of Uttam Kumar, S/O- Ram Kumar of vill- Dhanara, PS- Arsha which is situated at Kantadih more under Arsha PS

So, I returned back to PS with all arrested persons. Hence on return to PS I do hereby lodge suo-moto complaint against (1) Mantulal Sahis S/O Lt.
