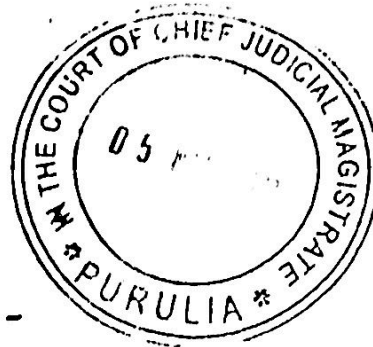
4. That the houses of the Complainant is at a distance from R.S./L.R. Plot No; 3374 whereas the House of the Accused persons are at a stone ~~etc~~ throwing distance from the R.S./L.R. Plot No.3374.

5. That on 7.2.2022 the accused persons by forming an unlawful assembly with a mala fide intention with arms in their hands such as Lathi, Tangi, Arrows, Axe trespassed into the complainant's land bearing R.S. Plot No. 3374 and began to raise wall with the help of Mason and labourers at about 7/8 P.M.

6. That the Complainant and his witnesses got information and ~~got~~ on getting the same, immediately had been to the spot and tried to forbade the accused persons from doing any mischief. But the accused persons Gharroud the complainant ~~and~~ in his neck, The accused Haresh Kumar tried to struck the Complainant with a Tangi but the Complainant any how saved his life. The accused persons also assaulted the Complainant by fists and blows. On the night of 7.2.2022 information was lodged at Arsha P.S.

7. That the accused persons on 9.2.2022 again criminally ~~en~~ trespassed into the land of the Complainant and began to resume illegal work of raising wall. The Complainant and his witnesses again came to the spot in the evening but the accused persons by seeing the Complainant's party became flared up and Accused ~~Badal~~ <sup>as Dileshwar</sup> and began to assault the Complainant with Lathi in his

hand and snatched away Rs.500/- from his pocket and the accused person began to pelt stone aiming towards the Complainant party.

8. That on 10.02.2022 the Complainant lodged diary before the Officer-in-charge Arsha P.S. by Registered Post with Ack-due.

9. That the Complainant under the impression that Arsha Police will take steps against the accused persons but no action was taken from the side of the Arsha Police So the Complainant lodge diary before the Superintendent of Police on 15.02.2022.


10. That the accused persons have committed an Office Under Section ~~427/ 447/ 323/ 379/ 307/ 506/ 34~~ I.P.C..

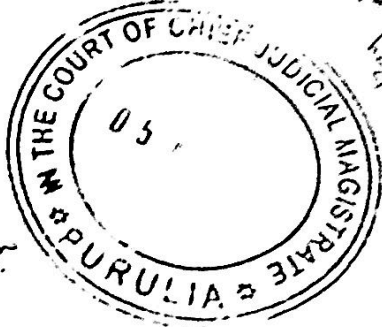
11. That the accused persons are still criminally intimidatng the Complainant and his witnesses who actually saw the occurance. Out of fear complainant could not go to his land.

12. That the Complainant is a poor man and he has no financial capacity to file prosecute the case in his personal capacity. So the Complainant invoke the provision Under Section 156(3) Cr.P.C.
