1 producing here with seized articles under proper seizure list (enclosed here with) i.e. (i) One  
 2 white colour nylon bag containing 04 Kg 100 grms "Ganja" and 02 (two) Pkt. Sample each containing 100  
 3 grms Ganja all are dully labeled and do hereby lodge sou-moto complaint against Nunaram Gorai @ Nuna  
 S/O Dulal Gorai of Herodih, PS- Arsha, Dist- Purulia to the effect that today (12.03.2022) at about 11.35 hrs  
 4 received a telephonic information from a reliable source that one Nunaram Gorai @ Nuna S/O Dulal Gorai  
 of Herodih, PS- Arsha, Dist- Purulia is selling Ganja (Cannabis) at his brick kiln situated at Vill- Herodih,  
 PS-Arsha, Dist- Purulia. On received such information, I diarized the fact in general diary vide GDE No. 441  
 Dt. 12.03.22 and after that myself along with (i) PSI Avijit Mondal (ii) C/156 Bijoy Hansda, (iii) C/971  
 5 Amit Manna all are of Arsha PS left PS equipped with govt. supplied arms and ammunition, Investigation  
 kit, weighing machine, white paper, gala, white cloth, carbon paper, stamp pad, envelope, seal of Arsha PS  
 and O/C Arsha PS and stamp pad etc vide Arsha PS GDE No. 442 Dt. 12.03.22 and C.C No. 516/22 Dt.  
 12.03.22 to work out the information by Govt. Vehicle No. WB-68X/2741. At about 12.35 hrs we reached at  
 Herodih morh and keeping the vehicle 100 mtrs from the brick kiln of Nunaram Gorai @ Nuna S/O Dulal  
 Gorai of Herodih, PS- Arsha, Dist- Purulia we reached at the brick kiln by foot. On reaching there we made  
 6 thorough search, we found a white colour nylon bag which is tied by a rope having bad smell. Accordingly I  
 open the bag and found full of intoxicated article seems to be cannabis, then strong suspicious arises in our  
 mind. I informed my superiors over telephone and as per their direction I try to contact with 01(one)  
 Executive Magistrate or any Gazetted Officer and try to contact B.D.O, Arsha but I failed to contact him  
 then I contact Shri Sanjib Biswas, C.I Sadar Circle, Purulia and requested him to remain present. At about  
 14.05. hrs Shri Sanjib Biswas, C.I Sadar, Purulia arrived at the spot. Mean while I asked the local villagers to  
 be with us before the arrival of Gazetted Officer and also requested them to remain present during such  
 7 operation. On arrival of Gazetted Officer in this respect I issued Notice to them namely (i) Pradip Kr. Gorain  
 S/O Doctor Gorain of Vill- Herodih, PS- Arsha, Dist- Purulia (ii) Somchand Hansda S/O Lt. Lalu Hansda of  
 Vill- Dhadkidih, PS- Arsha, Dist- Purulia and (iii) Bura Soren S/O Tushen Soren of do and we cordon the  
 PO. We searched for Nunaram Gorai but he was not available. After arrival of CI Sadar, Purulia Shri Sanjib  
 Biswas, Inspector of Police I again issued notice to them to searched our body before searched the bag by us  
 in presence of CI Sadar offering them to search the available police personnel present there, they conducted  
 a search of all the members of us but nothing objectionable could be found on our person except our  
 personal belongings, govt. arms ammunitions and items mention in the inventory list. Accordingly nil  
 seizure list was prepared in presence of CI Sadar after conducting search by the witnesses to us. Then we  
 searched the white colour nylon bag in presence of witnesses and gazetted Officer i.e C.I, Sadar. On  
 checking the white colour nylon bag it is found that the bag containing full of "Ganja" (Cannabis), then I  
 collected weight instrument locally. Measure the bag which contain 04 Kg 100 grms "Ganja" then I  
 collected 02(two) samples containing 100 grms each from the bag marking each sample as 'A2' & 'A3' in  
 presence of witnesses and C.I Sadar. Then I have seized the recovered "Ganja" including samples in  
 presence of witnesses and CI Sadar. After preparing a seizure list which is duly sign by the witnesses in  
 between 15.45 hrs. to 17.25 hrs. I prepared another inventory list containing weighing machine, some white  
 paper, used gala, rest white cloth, used carbon paper, stamp pad, seal, burnt candle etc. So it is clear that the  
 accused Nunaram Gorai @ Nuna S/O Dulal Gorai of Herodih, PS- Arsha, Dist- Purulia is running such  
 clandestine business since long. Hence he is liable for prosecution U/S 20(b) (ii)(a)/25/29 NDPS Act 1985.

After that I returned to PS and lodge a complaint against Nunaram Gorai @ Nuna S/O Dulal Gorai of Herodih, PS- Arsha, Dist- Purulia and register Arsha PS Case No. 33/22 Dt. 12.03.22 U/S 20(b) (ii)(a)/25/29 NDPS Act 1985 and endorse SI Anirban Dutta to investigate the case.
