Sub: To lodge FIR against owner and driver of one tractor bearing Reg. No. WB55A/6803 along with trolley loaded with sand (approx 60 CFT sand)


Sir,

In producing herewith 01 (one) tractor bearing Reg. No. WB55A/6803 along with trolley loaded with sand (approx 60 CFT sand). Today on 13.03.22 at about 19.45 hrs. I PSI Avijit Mondal of Arsha PS along with (i) C/-1516 Arnab Sinha of Arsha PS (ii) C/- 971 Amit Manna (iii) C/ 351 Pratik Karmakar both of Arsha PS, left PS area vide C.C No. 522 Dtd. 13.03.2022. During mobile duty act on source information we reached at the river bed of Bandu river behind Bhursa village under Arsha PS at 20.25 hrs, we conducted raid on the Bandu river behind Bhursa village under Arsha PS and found that 01 (one) tractor along with trolley attached with a hinge was present at there on the Bank of Bandu River. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Bandu river behind Bhursa village, fled away. Police rushed to the Tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the person & driver of said tractor. Hence, I seized the above noted tractor along with trolley loaded with sand (approx 60 CFT) and brought the tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolley and unknown others for investigation.
