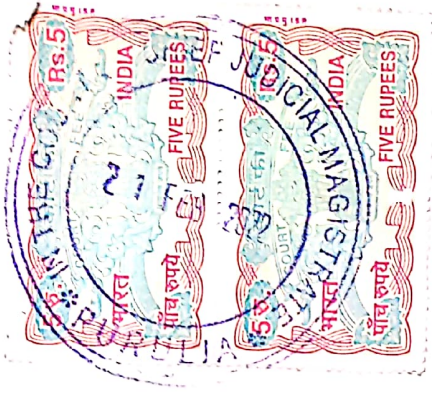

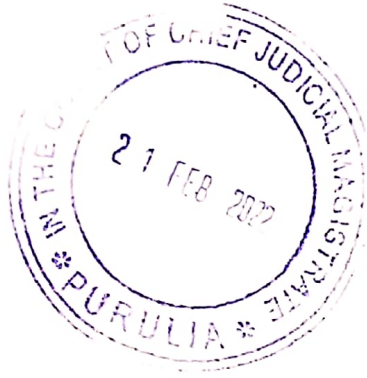

The above named complainant most respectfully begs to state as follows;nn

1. That the complainant, the accused persons and the witnesses are the residents of Village Kuchi within P. S Bagmundih and within the jurisdiction of this Court.
2. That as the daughter of the defecto complainant has filed a criminal case against the present accused person as the accused person badly assaulted the daughter of the complainant on 04. 07. 2021 since then the accused person has a logger head with the defect complainant.
3. That the accused person on 12. 12. 2021 set fire on the staged paddy within the courtyard of the defecto complainant and for that the paddy along with a Chala Ghar of the defecto complainant completely destroyed and for that the defecto complainant sustained a loss of about Rs. 40, 000/-.
4. That the complainant is a very poor person and he has no sufficient means to lead his life properly as all the paddy has been destroyed due to the fire set by the accused person. The accused person is very influential persons having money and muscle power. The accused person is threatening of and on to the complainant and asks him to not go to Police otherwise the complainant will face the consequence.

8. That the complainant is very poor and he is unable to bear the cost of court case and as such the complainant is filing the present petition
