Padmalochan Mondal of village Nischintapur, P.O- Dava Torang PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 14/03/2022 at about 10:10 a.m I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sajal Kumar Mahanty, Sr. OE, WBSEDCL 2. Biswajit Kumar, TSH, WBSEDCL, entered the premises of Sri Paritosh Mondal, S/O- Lt. Padmalochan Mondal of village Nischintapur, P.O- Dava Torang, PS- Bagmundi, Dist- Purulia and found Sri Paritosh Mondal was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Paritosh Mondal S/O- Sri Lt. Padmalochan Mondal committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sajal Kumar Mahanty, Sr. OE, WBSEDCL 2. Sri Biswajit Kumar, TSH, WBSEDCL. The inspection team left the premises at 10:20 a.m.
