On 14/03/2022 at about 10:25 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sajal Kumar Mahanta, Sr.OE, WBSEDCL, Biswajit Kumar, TSH, entered the premises of Sri Dilip Mondal, S/O- Lt.
