I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Hrishikesh Mondal, S/O- Sri Lt. Dinabandhu Mondal of village Nischintapur, P.O- Dava Torang PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 14/03/2022 at about 10:40 a.m I Sri Swapan Kumar Das, AE & Station Manager, Bagmundi CCC along with 1. Sajal Kumar Mahanta, Sr.OE, WBSEDCL 2. Biswajit Kumar, TSH, Bagmundi, entered the premises of Sri Hrishikesh Mondal, S/O- Lt. Dinabandhu Mondal of village Nischintapur, P.O- Dava Torang, PS- Bagmundi, Dist- Purulia and found Sri Hrishikesh Mondal was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Hrishikesh Mondal S/O- Sri Lt. Dinabandhu Mondal committed theft of electric power, So, I seized the following articles after preparing the seizure list in presence of 1. Sri Sajal Kumar Mahanta, Sr.OE, Bagmundi CCC, WBSEDCL 2. Sri Biswajit Kumar, TSH, Bagmundi CCC, WBSEDCL The inspection team left the premises at 10:50 a.m.
