On 22.03.2022 at about 11:35 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sri Sajal Kumar Mahanty, Sr. OE, WBSEDCL 2. Abdul Hasib, ACM, WBSEDCL, entered the premises of Sri Bhakta Ranjan Kumar, S/O- Late- Padmalochan Kumar of village Laldih, P.O- Hurumda, PS- Bagmundi, Dist- Purulia and found Sri Bhakta Ranjan Kumar was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA.
